ABSTRACT

Key Words : Jolly Roger, Pirates, Icon Theory, and Symbolic Interactionism.

This research aims to classify Jolly Roger into Icon Theory, and how Jolly Roger builds the pirate narrative in *the Pirates of the Caribbean Film* and *One Piece Anime*. Researcher used previous research conducted by Aryna Azzahra (2022) from Raden Mas Said State Islamic University entitled *A Symbolic Interactionism Study on The Meaning of Cape as found from Eastern and Western Superheroes* to be used as a reference. The similarity between the researcher and the reference source lies in the same theory, while the difference between the researcher's thesis and the reference source lies in the object being studied. The difference in the object is that the reference source analyzes the Superhero while the researcher analyzes the Jolly Roger Pirate.

Researcher use Icon Theory according to Nachbar and Lause (1992), and use Symbolic Interaction Theory according to George Herbert Mead (1934). Icon theory according to Nachbar and Lause is used to classify Jolly Roger into data tables. The Symbolic Interaction Theory according to George Herbert Mead is used to find out how the Jolly Roger can build a Pirate narrative.

Researcher used qualitative descriptive research. The data search process was carried out by taking pictures of the Jolly Roger or taking dialogue quotes that represent Jolly Roger user characters found in films and anime that had been determined by the researcher. The data source was taken from films with a pirate theme by watching limited episodes. Researcher use film as documentation and documentation techniques to collect data.

The results of the research show that the data found from the Icon Theory classification amounted to 36 data and the most dominant was the Functional Local Icon category data. This data shows that the Jolly Roger symbol represents a group of pirates and the Jolly Roger has a function so it is classified as a Functional Local Icon. Meanwhile, the narrative formed by Jolly Roger using Symbolic Interaction Theory amounts to 46 data and the most dominant is Strong's data. This data shows that Pirates are described as having strength.

Penelitian ini bertujuan untuk mengklasifikasikan Jolly Roger ke dalam Teori Ikon, dan bagaimana Jolly Roger membangun narasi bajak laut dalam Film *Pirates of the Caribbean* dan Anime *One Piece*. Peneliti menggunakan penelitian terdahulu yang dilakukan oleh Aryna Azzahra (2022) dari Universitas Islam Negeri Raden Mas Said Surakarta dengan judul *Kajian Interaksionisme Simbolik Tentang Makna Jubah yang Ditemukan pada Pahlawan Super Timur dan Barat* untuk dijadikan acuan. Persamaan antara peneliti dan sumber rujukan terletak pada teori yang sama, sedangkan perbedaan peneliti dengan sumber rujukan terletak pada objek yang diteliti. Perbedaan objeknya adalah sumber referensi menganalisis Superhero sedangkan peneliti menganalisis simbol Jolly Roger yang terdapat pada Bajak Laut.

Peneliti menggunakan Teori Ikon menurut Nachbar dan Lause (1992), dan menggunakan Teori Interaksi Simbolik menurut George Herbert Mead (1934). Teori ikon menurut Nachbar dan Lause digunakan untuk mengklasifikasikan Jolly Roger ke dalam tabel data. Teori Interaksi Simbolik menurut George Herbert Mead digunakan untuk mengetahui bagaimana Jolly Roger dapat membangun narasi Bajak Laut.

Peneliti menggunakan penelitian deskriptif kualitatif. Proses pencarian data dilakukan dengan mengambil gambar Jolly Roger atau mengambil kutipan dialog yang mewakili karakter pengguna Jolly Roger yang terdapat dalam film dan anime yang telah ditentukan oleh peneliti. Sumber data diambil dari film bertema bajak laut dengan menonton episode yang dibatasi. Peneliti menggunakan film sebagai teknik dokumentasi dan dokumentasi untuk mengumpulkan data.

Hasil penelitian menunjukkan bahwa data yang ditemukan dari klasifikasi Teori Ikon berjumlah 36 data dan yang paling dominan adalah data kategori Ikon Lokal Fungsional. Data tersebut menunjukkan bahwa lambang Jolly Roger mewakili sekelompok bajak laut dan Jolly Roger mempunyai fungsi sehingga tergolong Ikon Lokal Fungsional. Sedangkan narasi yang dibentuk oleh Jolly Roger dengan menggunakan Teori Interaksi Simbolik berjumlah 46 data dan yang paling dominan adalah data Strong. Data ini menunjukkan bahwa Bajak Laut digambarkan mempunyai kekuatan.

CHAPTER I

INTRODUCTION

A. Background of the Study

When talking about pirates, the first thing that comes to mind is looting, hard life and the symbol of the "Jolly Roger" in the form of a skull with crossed bones. Pirates are robbers at sea who act outside the law. The word pirate comes from Greek which means 'one who attacks', 'one who robs'. They usually live in groups using large ships and travel around the seas with the aim of hijacking ships and then selling the loot through the black market. Their goals are not political, they seek profit for themselves and only have the goal of having fun (Lewish, 2008).

Piracy on land and at sea dates to ancient times when towns close to the coast built gabled fences or concrete walls, hoping to keep pirates out. They were not always successful, which led the inhabitants to simply leave their homes and move inland as far away from the pirates as possible. Living near the coast provides its own vulnerability, which was massively exploited by the Vikings from Scandinavia in the eighth century. In the end the Vikings became residents of the lands they had plundered (Lewish, 2008).

Before pirate flags were symbolized by skulls and bones, pirate flags were depicted as solid black or blood red to give a frightening impression to the target to be attacked. It is still debated why the pirate flag was called the

Jolly Roger, with uncertainty as to where the expression originated. In 1724, Charles Johnson published a book called "A General History of the Pyrates". This is where the expression "Jolly Roger" is said to have originated, as Johnson quoted not one, but two pirates who named their flag the Jolly Roger: Bartholomew Roberts in June 1721 and Francis Spriggs in July 1723 (Charles, 2009).

Today, the Jolly Roger, a black flag with a skull and crossbones, is considered the standard pirate flag design. However, this is not the original Jolly Roger design, which has used many different settings over the years. In Charles Johnson's "A General History of the Pyrates," two pirates fly flags they call the Jolly Rogers, but neither Jolly Rogers has a skull and crossbones design. From this it can be ascertained that the Jolly Roger was not intended as a specific design description but rather a general term used to describe a pirate flag (Charles, 2009).

In other versions the term 'Jolly Roger' originally referred to any kind of flag flown by pirates and privateers (state sponsored pirates) and designs varied. The name 'Jolly Roger' has since signified one particular type of pirate flag: a black background with a white human skull above two crossbones. The origin of the name is not known for certain, but it is likely derived from the word 'Roger' which at that time meant a Devil, a figure often referred to as 'Old Roger'. A group of pirates who were hanged in Newport, Rhode Island in 1723 called their flag showing a skeleton holding an hourglass and a bleeding heart 'Old Roger'. The term 'roger' is also used

for wandering beggars or vagabonds and privateers are sometimes referred to as 'Sea Beggars', particularly in the Netherlands (Charles, 2009).

An alternative origin is the French term le jolie rouge ("beautiful red"), which was applied to the red flags commonly flown by privateers for centuries. Another possible origin (and there are many), is the Welsh pirate Black Bart Roberts (aka Bartholomew Roberts, c. 1682-1722) who was so famous for wearing bright red silk in battle that the French also nicknamed him le jolie rouge. Roberts was known to fly the skull and crossbones flag, among other things, on his fleet of ships so that this flag became the 'Jolly Roger' by association (Charles, 2009).

Term icon stems from the Greek word for image and is traditionally used to refer the religious objects developed in late medieval times in Eastern Europe as means of communicating significant beliefs and values of a faith to many illiterate believers. According to Nachbar and Lause

traditional icons convert objects into signs which everybody can read the same way that a traffic sign indicating a pedestrian crossing. For instance, using a shadow figure outline against a yellow background to convey its message and warning (Nachbar, 1992).

This research employs a Symbolic Interactionism approach which is a theoretical framework in sociology. Symbolic Interactionism is usually called as SI, consists of word symbolic and interaction (Carter & Fuller, 2015). According to communication dictionary interaction is a process which affect each other's behavior or activities among the society members. As for symbolic, it means to symbolize something (Effendy, 1989).

Symbolic originally comes from Latin language Symbolic (us) and Greek Symbolicos. Susanne said in her Science Book of Communication: Introduction that one of the human basics needs is the need of symbolization or using symbols, where human is the only mammals that often express themselves through symbols. Cassirer claimed that what makes human superior than other creatures is their ability as animal symbolicum. According to Oxford dictionary, interaction is the act of communicating with somebody, or between two things which make them have effect on each other (Mulyana, 2005).

The first previous study is thesis by (Azzahra, 2022) With the title is A Symbolic Interactionism Study On The Meaning Of Cape As Found From Eastern And Western Superheroes, by the publisher is Islamic University Raden Mas'said. And the second previous study is journal written by

(Wijaya Eka, Pranata, 2019). With the title Symbolic Interaction of Dead Students in Public School by the publisher is The Messenger Journal. The third previous study is a journal by (Husin, S. S., Ab Rahman, A. A., & Mukhtar, 2021). And the title is The Symbolic Interactionism Theory: A Systematic Literature Review Of Current Research and was published in Global Academic Excellence. The four previous study is a journal by (Muoghalu Caroline Okumdi and Abrifor Chiedu Akporaro, 2021) and the title is Social Interaction and social Relation: A Sociological Analysis. And the publisher is J Sociology Soc Anth. And the last previous study is journal by (Ramadhan.N and Engliana, 2021), with the title is Language Styles in Biography: A Descriptive Analysis of Ernle Bradford's 'The Sultan's Admiral: Barbarossa Pirate and Empire Builder, by the publisher is PGRI Indrapasta University.

Based on the background of the problems above, it can be concluded that this study examines the objects of the *Pirates of the Caribbean and Anime One piece* films using symbolic interaction theory and icon theory. This study reviews the depiction of pirates with humorous characters in the film world which are inversely proportional to the pirate characters in the real world. This study aims to examine the meaning of pirate symbols contained in the *Pirates of the Caribbean film and One Piece anime*.

B. Limitation Of The Study

This research focuses on the meaning of the Jolly Roger in the *Pirates Of The Caribbean film* and *One Piece anime*, these pirate symbols have their own meaning for a sailor or pirate. This pirate symbol is usually depicted on the flag of a pirate ship, as a tattoo on the body, or usually depicted on a piece of jewelry or other pirate attributes. The object of this research focuses on the *Pirates Of The Caribbean film* from season 1 and season 2 then for the *One Piece anime* focuses on episodes 890 to 1065 when members of the Straw Hat Pirates arrive on Wano Island to help Kinemon and his friends.

C. Formulation Of The Study

This study intends to formulate the problem in finding the meaning of pirate symbols in pirate films. The formulation of the research problem can be seen below:

- 1. What are the classification of Jolly Roger Icon as seen in *Pirates Of The Caribbean Film* and *One Piece Anime*?
- 2. How do the Jolly Roger Icon construct the pirates narrative as seen in *Pirates Of The Caribbean film* and *One Piece Anime ?*

D. Objective Of The Study

Based on the formulation of the problem above, this research is wished to cope the formulation of the problem include :

- 1. To explain the classification of Jolly Roger Icon as seen in *Pirates Of The Caribbean Film* and *One Piece Anime*?
- 3. To explain how do the Jolly Roger construct the pirates narrative as seen in *Pirates Of The Caribbean film* and *One Piece Anime*?

E. The Benefit Of The Study

From this research, the researcher hopes that this study has the benefits that are divided into theoretical and practical benefits as follows:

1. Theoretical Benefits

The theoretical benefit of this research is to provide information from further explanations about what the meaning of symbols seen in the icon of Jolly Roger and to enrich the researcher knowledge about the relationship of symbolic interaction with pirate films.

2. Practical Benefits

The practical benefit of this research is that the reader gets information about the meanings of the symbols contained in the *Pirates of the Carribean and Anime One piece*.

F. Definiton of Key Terms

1. Pirates

Pirates are one of the crimes that have existed since ancient times until now. Organized crime committed by a group of people using sailing

ships who came to rob, plunder, burn and torture their captives. Their reputation can make a city subdued and subject to their rule (Lewish, 2008).

2. Jolly Roger

Jolly Roger, commonly known as the pirates flag. This flag was usuall used by pirates in Europe and The Caribbean in the 17th century, this flag served as a symbol or sign that pirate ships would plunder. Various pirates versions of the Jolly Roger existed through the centuries, for example Calico Jack Rackham's pirates flag replaced the image of crossbones with crossed cutlass sword (Charles, 2009).

3. Symbolic Interactionsim

Theory of Symbolic Interactionism has the understanding that people in every environment respond to every element in the environment around them based on their subjective understanding. Then based on social interaction and subjective understanding of each individual, a different meaning arises in each community environment. Symbolic interactionism is a theoretical framework from sociology that explains how every society is created and maintained through the repeated actions of each individual (Carter & Fuller, 2015).

CHAPTER II

LITERATURE REVIEW

A. Theoretical Background

1. Sociological Approach

The word sociology comes from the word Lation socius (companion) and the Greek word logos (science of). So, the literal meaning of sociology is the study of friendship. In the textbook definition, sociology means studying a relationship or social interaction in society. Frank Wilson Blackmar was a sociologist who first introduced sociology at the University of Kansas in 1890 in the Elements of Sociology course, and this is one of the oldest courses in the United States (Giddens, 1986). Sociology studies many things from the relationship between one individual and another individual, between one individual and a group, and a group with another group. Apart from that, social relationships that exist in cyberspace or the internet are an aspect that can be studied using sociology.

Because pirate symbols are formed from the interaction of one group and each pirate group has its own pirate flag. So researcher need to use a branch of sociology to examine the meaning of each pirate symbol. Furthermore, researcher used Symbolic Interaction theory and icon theory to find out the meaning contained in pirate symbols in films.

2. Icon Theory

The term icon stems from the Greek word for image and is traditionally used to refer the religious objects developed in late medieval times in Eastern Europe as means of communicating significant beliefs and values of a faith to many illiterate believers. According to (Nachbar & Lause, 1992) traditional icons convert objects into signs which everybody can read the same way that a traffic sign indicating a pedestrian crossing. For instance, using a shadow figure outline against a yellow background to convey its message and warning. However, traditional icons (and their popular counterparts) are more than mere signs. They express a deep-seated, significance message of faith which binds a community or belief together, and impart magical powers to those who venerate the icon.

A cross or crucifix, for example, is like a traffic sign from previous example which is a symbolic representation of an idea expressed without words; but a cross or crucifix also serves as an expression of religion beliefs which unites its owner with others of the same faith and magically ties the individual believer into an intimate relationship with God. A sign is just a signal; however, an icon is also a talisman.

Popular icons perform similar roles in the realms of secular belief and values. Like the traditional icon, popular icons are also important elements of the group's beliefs and values, and impart magical powers to the iconic group. For example, Americans are united in a culture-wide obsession with cars. They treat the act of buying automobiles in any less of good condition as treason. (Nachbar & Lause, 1992) furthermore explained that the cars are used as expression of their belief in individual freedom (everyone should be able to own one to drive wherever and whenever they wish), material success (since it mirrors how much earnings they earn), and endless abundance. If cars were simply insignificant (non-iconic) objects designed solely for transportation, then there would be no reason they could not look all exactly alike and designed only for fuel efficiency and safety, and used to carry as many people as possible. This is the case of taxicab from heil, which means it is a non-iconic car.

All icons share three characteristics, they are: a) objects, b) express important popular beliefs and values, and c) convey magical powers to the group. However, it is important to note that they also have their own distinction to be drawn amongst the various type of icons as well. The broader vision is between the objects which have no rule other than to express elements of a popular mindset (purely expressive, or pure icons) and those which have something in addition to convey the beliefs (have other function other than the symbolic one). It's also possible to classify popular icons according to the size and nature of the group which accepts the icon and finds it meaningful. Icon which are significant only to a given individual of very small group (e.g., family) are termed as Personal icons; objects which have iconic significance to a small community, town, or area are called Local icons; and those representations of the beliefs and values of a significant cultural subgroup or of the cultural are labeled as Cultural icons.

These categories cut across each other in a crosshatch fashion to produce a relationship summarized in the chart below:

- a. Pure Personal Icons: Objects which have no function other than to symbolize a meaning important to an individual and the small group immediately surrounding him.
 - b. Functional Personal Icons: Objects which have a function in addition to their symbolic meaning for an individual or small group.
- c. Pure Local Icons: Objects which have no function other than to symbolize a meaning or belief important to a small community or town.
- d. Functional Local Icons: Objects which have a use in addition to their symbolic role of representing beliefs and values meaningful to a small community, group, or town.
- e. Pure Cultural Icons: Objects with no function other than to symbolize significant beliefs and values meaningful to important cultural subgroups and/or to the culture as a whole.

f. Functional Cultural Icons: Objects which have a use in addition to the expression of emotional and/or intellectual meanings important to the entire culture and/or to sign sub-groups within the culture.

Understanding icons characteristics won't be enough unless the value behind the icons creation were also explained (Nachbar & Lause, 1992). There were various values that can be placed upon those icons, and by analyzing which value is the most dominant in an icon, one value can be chosen. The icon values are:

- a. Appearance of the Icon: Determined by seeing the shape, color, and size of the icon for searching the significance of the icons.
- b. History of the Icon: Determined by searching the icon's origin. For instance: the time and place creation of the icons; the possibility of cultural circumstances that made the icon development succeeded or is needed for success result; and the existence of the icon came from the representative of important myths, beliefs, or values.
- c. Evolutionary Change in the Icon: Determined by looking whether 21 there's alteration of the icon's meaning over the time that affected its appearance, its overall significance, or both.
- d. Iconic Group: Determined by analyzing the group that the icon represented. It can be a mass culture such as country or sub-groups that can be analyzed based on the demographic characterizations including age, sex, class, religion, etc.

e. Exploitation of the Icon: Determined by the existence of groups that tried to use the significance of the icon's meaning in different ways to make it appealing to the masses.

3. Symbolic Interaction Theory by George Herbert Mead

Researcher used the Symbolic Interactionism approach for this research. Symbolic Interactionism is a scientific branch of Sociology (Carter & Fuller, 2015). Symbolic interactionism is often referred to by the abbreviation SI. According to (Effendy, 1989) in the communication dictionary, interaction is a process of influencing behavior or communication that is established between members of society. Symbolic itself is symbolizing something.

Theory of Symbolic Interactionism has the understanding that people in every environment respond to every element in the environment around them based on their subjective understanding, then based on social interaction and subjective understanding of each individual, a different meaning arises in each community environment. Symbolic interactionism is a theoretical framework from sociology that explains how every society is created and maintained through the repeated actions of each individual (Carter & Fuller, 2015). From this statement it can be concluded that humans interact and communicate so that a meaning is created through language and symbols. With the existence of communication in each society and different culture in each region, differences in understanding of the meaning of symbols arise in each region.

Symbolic originally comes from Latin language Symbolic (us) and Greek Symbolicos. Susanne said in her Science Book of Communication: Introduction (Mulyana, 2005) that one of the human basics needs is the need of symbolization or using symbols, where human is the only mammals that often express themselves through symbols. Cassirer claimed that what makes human superior than other creatures is their ability as animal symbolicum. According to Oxford dictionary, interaction is the act of communicating with somebody, or between two things which make them have effect on each other.

The history of Symbolic Interactionism theory cannot be separated from the thought of George Herbert Mead (1863-1931). Mead was born in Hadley, one small town in Massachusetts. He became a professor at Oberlin campus, Ohio, then proceed to move teaching from one campus to another until he was invited to move from University of Michigan to University of Chicago by John Dewey. This is when Mead started making a record of contributions to social science by launching the theoretical perspective which later will become Symbolic Interaction Theory. As a result, Mead was known as social psychologist expert in sociological field. Mead settled in Chicago for 37 years, until he died in 1931 (Rogers, 1994).

There are many researcher other than Mead who also used symbolic interactionism approach where in this theory it provides a relatively specific approach to the science of human group life and human behavior, and has made many intellectual contributions, including John Dewey, Robert E.

Park, William James, Charles Horton Cooley, Ernest Burgess, James Mark Baldwin. The generation after Mead was the beginning of the development of Symbolic Interactionism, where at that time Mead's premise was split into two schools that differ in methodology, they are (1) the Chicago School pioneered by Herbert Blumer, and (2) The Iowa School pioneered by Manfred Kuhn and Kimball Young (Ahmadi, 2008).

The Chicago school which was pioneered by Herbert Blumer (who coined the name Symbolic Interaction in 1969) and his students, is the result of Blumer 13 who continued the research that had been done by Mead. Blumer takes a qualitative approach, which believes that the study of humans cannot be equated with the study of inanimate objects, and many thinkersin the Chicago school take an interpretive approach based on the pioneering thoughts of George Harbert Mead (Ardianto & Q-Anees, 2007). Blumer thinks that researcher need to put their empathy with the subject matter to be studied, try to enter the experience of the object understudy, and try to understand the values possessed by each individual. The scientific approach of the Chicago School emphasizes biographies, case studies, diaries (diaries), autobiographies, letters, indirect interviews, and unstructured interviews.

The Lowa School was pioneered by Manford Kuhn and his students (1950-1960), by taking a quantitative approach, where many of these circles adhere to the epistemological tradition and post positivist methodology

(Ardianto & Q-Anees, 2007). Kuhn believes that the concept of symbolic interactions can be operationalized, quantified, and tested. This school of thought develops several new perspectives on "self-concept" (West, 2008). Kuhn tried to maintain the basic principles of the interactionists, where Kuhn took two steps from a new perspective that was not found in the previous theory, namely: (1) clarifying the self-concept into a more concrete form; (2) to achieve the first thing, he used quantitative research, which in turn led to microscopic analysis (Stephen W. Littlejohn, 2010). Kuhn was in charge of a technique known as the [twenty-question personal attitude test" [the Twenty statement self-attitudes test (TST)]. The twenty-question personal attitude test was used to measure various personal aspects. At this stage, the 14 difference between the Chicago School and the Iowa School is clear because the work of Kuhn and his friends is very different from the flow of symbolic interactionism. This weakness of the Kuhn method is deemed inadequate for investigating process-based behavior, which is an important element in interactions. As a result, a group of Kuhn's followers switched and created the new Iowa School. The new Iowa school was pioneered by Carl Couch, in which the approach is carried out regarding the study of coordinated interaction structure of behavior was carried out through a series of events recorded by video recording (video tape).

Symbolic Interactionism Theory is a newcomer theory in the study of communication science and literature, which is around the early 19th century ago. The theory of SI continues to develop until now, where SI is indirectly a branch of sociology from an interactional perspective (Ardianto & Q-Anees, 2007). According to interactional perspective, SI is one of the perspectives that exist in communication studies, which is perhaps the most humanist (Azzahra, 2022). This perspective knows to emphasize the grandeur and masterpiece of individual values above the influence of existing values a lot. It also considers that each individual in himself hasthe essence of culture, interacts in the social community, and produces the meaning of ideas that is agreed upon collectively. In the end, it can be said that every form of social interaction carried out by each individual will consider the individual's side, this is one of the characteristics of an interactional perspective that embodies symbolic interactionism.

Also emphasizes that the relation and the essence of this approach is the individual itself (Soeprapto, 2007). Many experts of this research also agreed that the individual is the most important aspect in this sociological concept. They say that individual objects can be directly studied and analyzed through their interactions with other individuals. Symbolic interaction basically describes a frame of reference to understand how humans, together with others, create a symbolic world and how the world shapes human behavior (West, 2008).

Symbolic interactionism exists because the basic ideas in forming meaning come from the human mind about self, their relationship in the middle of social interaction, and having the ultimate goal to mediate and interpret the meaning in the Society where the individual lives. As noted by Douglas (1970) in (Ardianto & Q-Anees, 2007), meaning comes from interaction, and there is no other way to form meaning, other than by building relationships with other individuals through interaction. The brief definition of three basic ideas of Symbolic Interactionism include:

- a. Mind is the ability to use symbols that have the same social meaning where each individual must develop their thoughts through interaction with other individuals.
- b. Self is the ability to reflect on each individual's self from the assessment of other's opinion or point of view, and Symbolic Interaction (SI) is a branch of sociological theory that expresses The-Self and the world outside.
- c. Society is a network of social relationships that are created, built, and constructed by each individual in the community. Each individual is involved in the behavior the activities that they have actively chosen with consent, which in turn leads people in the process of taking a role in their society.

Mind, Self, and Society is George Herbert Mead's most famous work, in which the book focuses on three themes of concepts and assumptions needed to formulate a discussion of Symbolic Interaction (SI

-). Those three themes of Mead's conceptual thoughts that underlie Symbolic Interactionism include (George H. Mead, 1934) :
 - a. The importance of meaning for human behavior.
 - b. The importance of the concept of self
 - c. The relationship between individuals and society

The second theme of SI proposed by Mead is the importance of Self Concept. This theme emphasizes the development of self-concept through the individual actively which is based on social interactions with other people. According to (LaRossa, R., & Reitzes, 1993) this theme. Has two additional assumptions, they are:

- a. Individuals develop self-concept through interactions with others.
- b. Self-concept forms an important motive for behavior.

4. Pirate

Piracy has occurred since ancient times, until the golden peak of pirates occurred in the mid-16th century to the early 17th century. Piracy means climbing and plundering, but piracy by pirates does not stop there, they also attack and plunder on land so that cities adjacent to the coast build sharp fences or concrete walls hoping that pirates cannot enter cities, but they are not always successful. So that the residents of the towns adjacent

to the coast prefer to leave their homes just like that and prefer to move to inland areas, as far as pos sible from pirates (Lewish, 2008).

Piracy has been a reality of life on Earth ever since humans first built ships and sailed to distant lands to trade, search for loot, and go on expeditions in search of new islands. In ancient times, Egyptian, Greek, and Roman merchants were constantly harassed by pirates who controlled the shipping lanes. The pirates hid, waiting for their prey, among the many scattered islands and long indentations that the ocean made on the eastern shoreline of the Mediterranean. Most of the coast is uninhabited, which is not surprising given that all it offers is rocky arid terrain that cannot support a large population. In the "quiet" winter pirates sometimes barter supplies with individuals or families facing hardships due to the harsh environment. But they also need to spend time and effort scavenging what the local area can provide (Lewish, 2008).

Courageous, better-navigated pirates such as Cilicia based in what is now southern Turkey braved the storms and sailed the winter seas of the Mediterranean to further their trade. But most other pirates ceased their activities during the "quiet" months, and remained hidden in creeks and coves or behind long stretches of land where enemies were hard to find and dangerous to try. The coastline of Lycia, now Anatolia, Turkey, is divided into small inlets, which can be used as hiding places for pirates.

In those days, navigators sailed with land within sight, a practice known as hugging the coast, of course providing pirates with a golden opportunity, allowing them to surprise passing ships and emerge seemingly out of nowhere to seize the cargo and take them prisoner. ship crew. Once done, the pirates sailed back to their hideout where whether it was "quiet" or bustling, they were nearly impossible to detect. This is because the ship that was usually used by ancient pirates was the myoparo, a light and fast ship that was easy to maneuver in shallow coastal waters. Ancient Greek pirates made their winter bases on the volcanic archipelago of Aeolia, today's Lipari Islands, off the north coast of Sicily, for almost 2500 years. Illyrian pirates holed up on Istria, a peninsula in the Adriatic Sea, today's Croatian coast (Lewish, 2008).

The golden age of pirates occurred around 1730, when there was a massive increase in the number of pirates in various seas of the world. Some of them left the Caribbean to escape the harsh Ratisbon Agreements, others chose to continue piracy rather than accept the amnesty offered by Roger Woodes. Pirates of the golden age also sought wealth in the Indian Ocean region, where wealth was available to successful pirates who could plunder cargoes of highly valuable silk, jewelery and ivory, and spices such as pepper, nutmeg and cinnamon (Charles, 2009).

5. History of Jolly Roger

There are many versions about the beginning of the use of skull images as a pirate symbol. The "golden age" of pirates has given us all images of pirates such as earrings, prosthetic limbs, and a parrot perched on a man's shoulder with a scar across his face. In that era, the use of the Pirate symbol or often called the Jolly Roger using a skull and crossbones on a black background is known today to mean resistance to the power of a country (Kuhn, 2020).

Later, the Jolly Roger was not only known by the black flag. However, where did the skull and crossbones symbol come from? Osiris for ancient Egyptian belief. Another possibility is that the Jolly Roger symbol is similar to the Chi-Rho symbol which comes from Greece, the Chi-rho is claimed to be the monogram "Christ", Christians use it to be used as a grave marker for each other. Meanwhile, the skull symbol has long been used by people of Tibetan, Nepalese, and Roman culture. It is believed that a number of groups of Barbary or Corsair Pirates (as Pirates or Privater Muslims) have used images of skulls on their flags since the 16th century. However, in historical records the use of the Jolly Roger has only been found in the British Admiralty Report from the end of the same century, precisely in July 18, 1700 (Benjamin, 2022).

Many historians later agreed that the British pirate referred to in the British Admiralty Report was Emanuel Wynn, the first sea pirate to use the

Jolly Roger. According to the report, Wynn is said to have raised a black flag bearing a skull, cross bone and an hourglass to give a warning to surrender to a ship about to be plundered. However, no one knows for sure when the term Jolly Roger began. There are two versions that tell the origin of the title Le Jolie Rouge. The first version tells that the term became a nickname for the French people for Captain Bartholomew Roberts who often wore red clothes. Then the second version tells that Le Jolie Rouge is used as an expression that is often used by French privateers (Benjamin, 2022).

World History notes that the Jolly Roger was not only black, some pirates flew flags of other colors, such as red or green. Jolly Roger has many meanings, one of which is as an early warning to ships that will be plundered, then if the hunted ship does not surrender, the Pirate Lajut raises a red flag which means blood is ready to be shed in war. Then as time went on the Pirate flag was not only used by Pirate members. In the 18th century, the Jolly Roger crossed over to the other side of the law when it was chosen as the British regimental emblem. Even until the 20th century the Jolly Roger was often used on British Navy submarines. Not only the British, the Jolly Roger was also used by the Polish army and warships belonging to the United States, such as the USS Kidd (Benjamin, 2022).

6. Synopsis

a. Pirates of the Caribbean Film

Pirates of the Caribbean film is a film series produced by Jerry Bruckheimer, based on the Walt Disney amusement park attractions, to date this film has 6 sequels and 3 of them were directed by different people. The film's first release was in 2003, set in the 18th century during the golden age of pirates in the Caribbean Sea. The Curse Of The Black Pearl became the title of the first release of this film, Captain Jack Sparrow, played by Johny Depp arrives at Port Royal Harbor, Caribbean. Jack Sparrow's arrival was inappropriate because at night Barbossa, his former staff, intends to attack the city in Port Royal Harbor, to take valuable coins owned by the Governor's daughter, Elizabeth Swann, because these coins are related to the curse that has turned pirates into undead.

b. One Piece Anime

One Piece anime is one of the Japanese anime that tells about a pirate adventure. The story of the beginning of this anime begins by telling a character named Luffy, who from a young age has aspirations to become the Pirate King. In his early life, Luffy was entrusted by his grandfather named Garp to Dadan, a leader of the Mountain Bandits group. Luffy grew up with 2 of his friends who were considered like his siblings, named Ace and Sabo. When they reached adulthood, Luffy and his friends started to leave Dadan to pursue their own dreams. Luffy, who dreams of becoming a Pirate King, begins his voyage by recruiting his members one by one.

B. Previous Studies

To support the research and finds the best result, here are several previous studies related to this research, namely:

The first previous study that was used by Jumalladi Akbar (2020) examines the object of *One Piece* anime with the thesis title "*Motivation of* the character of Nico Robin in Anime One Piece in the Ennies Lobby Chapter by Eichiro Oda", University Darma Persada. Using the Humanist theory, Abraham Maslow's Hierarchy and the method used in this study is a qualitative description. Maslow's Hierarchy of Needs Theory is a psychological theory that is useful for generating motivation in a person in meeting their daily needs. According to Maslow, the needs of everyone are divided into five levels, from the basic level or called Physiology, then the second level is the need for security, then the third level is social needs such as love and affection, the fourth stage is the need for appreciation, and the last is the need for self-actualization. This research resulted in the motivation of Nico Robin's character that emerged since he realized the loyalty of his Straw Hat Pirate friends to save him from the pursuit of the World Government's Pol Cipher Agent, because of that Nico Robin fulfilled his need for security by entrusting his whole life to the group Straw Hat (Akbar, 2020).

The second previous study is a thesis written by Dicky Mylano Irawan from IAIN Purwokerto which discusses Racism in *One Piece* Anime using Hans George Gadamer's Hermeneutics theory, with the thesis title

Racial Representation in the *One Piece* Anime Series. This thesis use a qualitative research method. The conclusion of this study is that researcher found racial elements which are divided into three levels according to Gadamer's hermeneutic theory, the three levels are reality level, representation level, and ideology level. then the researcher concluded that there was a separatist ideology by proving the scenes in the anime in the form of torture, slavery, oppression, and murder committed by the world government (Dicky, 2018).

The third Previous Study is a thesis entitled War Ethics in the Anime *One Piece* Movie Z in an Islamic Perspective written by Asyhari Amri, a graduate student from Sunan Kalijaga State Islamic University, Yogyakarta. This study discusses the ethics of war from an Islamic point of view in *One Piece Movie Z* using qualitative data collection methods. From the research written by the researcher, it can be concluded that in Islam it prohibits hostility, murder, betrayal and plundering, even though Islamic teachings always teach kindness to fellow beings. this is evidenced by the scenes of the antagonistic characters in the *One Piece Movie Z* film (Asyhari, 2018).

The fourth previous study is a thesis entitled Translation of *Wakamono Kotoba* in *One Piece* Manga written by Muhammad Nur Ramadhan, a Diponegoro University student. Based on this thesis, the researcher discussed how the method and translation of *Wakamono Kotoba* in translating ST and TT, based on this thesis, the researcher could conclude that the data collection technique used qualitative methods. From the

research conducted, the researcher concluded that there were several conclusions obtained, one of which was, of the 4 methods that emphasized SL, only the literal method could be used in translating *Wakamono Kotoba*. While the translation method use and emphasizes TL, of the 4 methods there are only 2 methods used, namely the free and communicative method (Muhammad, 2019).

And the last previous study is a thesis entitled Charles Sanders Peirce's Semiotic Analysis of Bushidou Ethics in *One Piece* Comics written by Eka Athmaja Putra, a student at Gajah Mada University, Yogyakarta. This thesis discusses the signs in *One Piece* comics that reflect Bushido ethics. The method used is qualitative and use Charles Sanders Peirce's theory of semiotic analysis. According to Peirce, a sign is something that represents something else, Peirce use the Triadic Triangle which has three main components, namely: Object, Representamen, and Interpret. The analysis was carried out by examining each piece of *One Piece* comic that was identified as having a sign related to the 7 values in Bushidou's ethics. The results of this study are that each character in the *One Piece* comic in a certain comic chapter has the seven ethical values of Bushidou, namely courage, justice, honesty, decency, honor, and loyalty (Athmaja, 2019).

The five previous theses show that different theories are used. From the five previous study, it can be seen that no one has used Symbolic Interaction theory and Icon Theory. In the five previous study, no one has used the Jolly Roger as a research object.

CHAPTER III

RESEARCH METHOD

A. Research Design

This study use a qualitative descriptive approach because this research is related to human behavior and human communication which will later produce interaction symbols. Qualitative research is a research to explore and understand the meaning that a number or individuals or groups ascribe to social or humanitarian problems. Creswell explained that in qualitative research, knowledge is built through the interpretation of multiple perspective that various from the input of all participants involved in the research, not only from the researcher (Creswell, 2009).

The research design expressed by Creswell relates to procedural research which includes data collection, analysis, and interpretation intended by the researcher for his research (Creswell, 2009). According to Stake, qualitative research tends to be an attempt to produce a situational description and interpretation of an event that researcher can offer to colleagues, students and other parties to modify. Based on this it can be understood that qualitative research tends to find something through a description process rather than a counting or enumeration process (Robert, 2010). According to Muhammad's understanding, qualitative research is related to description, descriptive is the nature of qualitative research in which the data is in the form of a description of the research object. From this it can be understood that a study can be analyzed with qualitative

research because the data is in the form of words, phrases, and sentences (Tahir, 2011).

However, qualitative research also has its own weaknesses, this method also requires interpretive investigations in which the researcher makes his interpretation of what he sees, hears and understands. After the research report is issued, the researcher use his interpretation about the research. Because of this, the method may indicate some qualitative research problem which is stated in as below (Creswell, 2009):

"Characteristics of a qualitative research problem are: (a) the concept is immature due to a conspicuous lack of theory and previous research, (b) a notion that the available theory may be inaccurate, inappropriate, incorrect, or biased; (c) a need exist to explore and describe the phenomena and to develop theory; or (d) the nature of the phenomenon may not be suited to quantitative measures."

Further explanation about this research is about the main reasons why using qualitative research, which means this research is exploratory in nature. This motive was found because the topic of research has not been written much and researcher tend to build understanding of what is heard. This statement was stated by Morse clearly in (Creswell, 2009).

"Qualitative research is exploratory and is useful when the researcher does not know the important variablesto examine. Thistype of approach may be needed because the topic is new, the topic has never been addressed with a certain sample or group of people, and existing theories do not applywith the particular sample or group under study".

Based on this explanation, researcher often choose and use a theory in their research to help explain or formulate problems which can be in the form of arguments, discussions, or justifications. According to (Creswell, 2009), there are several ways to use theory in qualitative research, including:

"In qualitative research, the use of theory is more varied. Researcher can produce a theory as a result of a series of research that has been done and place it at the end of a project as in grounded theory. In other qualitative research, this comes first and provides a picture that forms a question to ask, as in ethnographic or advocacy research".

B. Data and Data Sources

According to (Sudaryanto, 1993), data is considered as material to be used in a study to describe the research object. Data can be in the form of discourse, sentences, clauses, phrases, or words obtained from books, magazines, newspapers, advertisements, television, films, brochures, and others. In relation to qualitative research, as stated by (Creswell, 2009), qualitative data is not presented in the form of numbers but in the form of words or pictures. So it can be understood that qualitative data consists of pictures, words, phrases, clauses, and sentences.

In research, there are various methods used to collect information, including primary data and secondary data. Primary data is data obtained by researcher directly (from first hand), while secondary data is data obtained by researcher from existing sources (Yuniati, 2021). In this study, the primary data will be taken from the *Pirates Of Caribbean Movie and One Piece* Anime, while the secondary data will be in the form of websites, journal reviews, and articles.

C. Research Instrument

Another explanation explains that qualitative methodologies tend to use the researcher themselves as the key research instrument. This statement

was put forward by (Creswell, 2009) that "Researcher as key instruments of qualitative research collect the data themselves through examining documents, observing behavior, or interviewing participants". From this it is known that each step in this research makes the researcher the main key of the research itself, the researcher is the party that actually collects information and does not rely on questionnaires or instruments developed by other researcher. So this research does everything that is needed in research by using its knowledge and energy to search, collect, and analyze data to complete the research. Researcher also use component tables intended as data placement.

D. Data Collection Techniques

Data collection plays an important role in statistical analysis. In research there are various methods used to collect information. Data collection techniques refer to the way researcher obtain observed data. In collecting data, a technique called library research was used (Subroto, D. E., & Kunardi, 1992). Literature research means data collected from written sources such as magazines, newspapers, brochures and others. In this case the data obtained from this research comes from film and animation.

The technique of data collection in qualitative research has some steps which are stated in (Creswell, 2009) they are: (a) setting the boundaries for study, (b) collecting information through observations, interviews, documents, and visual materials, and (c) establishing the

protocol for recording information. According to those explanations, the researcher needs to do some steps in collecting the data, there are:

- 1. Researcher find and determine films and anime that will be used for research material with the chosen theory. The selected films include Pirates of the Caribbean series 1 (2003), series 2 (2006), series 3 (2007) directed by Gore Verbinski, series 4 (2011) by Rob Marshall and series 5 (2017) by Joachim Ronning and Espen Sandberg then the anime chosen was *One Piece* (1997) by Eichiro Oda.
- 2. Researcher watched selected films and anime.
- 3. Researcher examine and determine which episodes and minutes will be included in the research data criteria. The selected data must be related to theory, then the researcher checks all the data again. Then collect data and classify it based on problem relationships.
- 4. Researcher Coding data.

E. Data Validation Techniques

After the data is collected, the next step is to verify the accuracy of the data to determine the validity of the data. According to (Creswell, 2009)

"Qualitative validity means the researcher checks the accuracy of the

findings using certain procedures". Based on this statement, it is known that to verify data, researcher need to apply several procedures. The procedure applied is member checking as in validating data. This is because (Creswell, 2009) stated that validation is the most common way used to develop data trustworthiness in qualitative research. (Creswell & Miller, 2000) state that validation is the validity of the data based on the validator, data is categorized as good data if the data is valid. To get the validity of the data by researching and determining the accuracy of the findings using a validator, the form of data validation is document analysis.

This study use a member check strategy to check the accuracy of the data. This strategy is clearly stated in (Creswell, 2009) which is to use member checking to determine the accuracy of qualitative findings through submitting a final report or description or certain themes back to participants and determining whether the participants feel that the findings are accurate. In this strategy, the researcher needs an expert who is able to understand the theory related to related data to ascertain the true value of the data. In this research, researcher used sociologists and literature studies as validators of this research. This research was confirmed by Shabrina An Adzani, M.A. to verify and validate the research data, as well as a lecturer at a university in Surakarta.

F. Data Analysis Techniques

After the data was collected, researcher analyzed the data by carrying out categorization, description and synthetic processes. To describe

and interpret the data studied, data reduction is needed. In short, data analysis is a systematic process of analyzing collected data. According to (Sugiyono, 2007), there are three analytical activities in qualitative descriptive. The activities referred to are data reduction, data presentation, and drawing conclusions.

Data reduction is the process of selecting and classifying data that is considered important. In the research process, researcher will obtain a lot of data, therefore researcher must be smart in selecting data so that they can provide information that can be used in research. Thus the initial stages of data reduction must be carried out by researcher. Based on the concept of data reduction, data reduction was chosen in order to solve difficulties in processing data. Briefly, the steps that must be taken in analyzing data are:

- 1) Researcher collect data through selected Anime and Films.
- 2) Researcher select, identify and focus data based on the problem formulation that has been created.
- 3) After selecting data, the researcher displays the data in a research table.
- 4) Researcher display data and interpret the results to find relationships between data and research.
- 5) Drawing conclusions.

CHAPTER IV

FINDINGS AND DISCUSSIONS

A. Findings

The researcher presents data analysis in this chapter. There are two parts, first is the research findings and second is the discussions, this research analyzes the classification of Jolly Roger in the *Pirates Of The Caribbean* Film and *One Piece* Anime and how Jolly Roger builds the story in the Pirates Of The Caribbean Film and *One Piece* Anime. The entire analysis will use the same theory, namely using Icon Theory by Jack Nachbar and Kevin Lause (1992) and using the Symbolic Interaction Theory approach proposed by George Herbert Mead (1934).

In the fourth chapter, the researcher presents the data. Researcher found 36 images as evidence of Icon theory and 46 images as evidence of Symbolic Interaction. And find 13 symbolic interactions that build a pirate story.

1. The classification of Jolly Roger Icon in the *Pirates Of the Caribbean Movie* and *One Piece Anime*

According to Nacbar and Lause, Icon Theory is divided into Six categories are given to divide the icon based on whether it's purely for belief expression (Pure icons) or has other function (Functional icons), and based on the size and nature of the group that believes the icon. There are Personal Icons (icon is only significant to the individual or very small group such as family), Local Icons (icon is significant to a small community, town, or area), and Cultural Icons (icon significant to a significant cultural sub-group or the culture as whole) (Nachbar & Lause, 1992).

1) Pure Personal Icon

In the *Pirates of the Caribbean* Film Season 1,2 and the *One Piece* Anime from Episodes 890 to 1065, there are 9 PPI icons that can be found. Among them are:

a) Minute 1.18.47 Season 1 of The Pirates Of The Caribbean film

In this scene, Elizabeth and William are chatting and treating the wound on Elizabeth's hand. It turns out that Elizabeth lied to Barbossa that her name was William because Elizabeth was afraid that something would happen to William. Then William Turner learned that the medal left by his father was still there and was being carried by Elizabeth Swan. This icon is classified as PPI, Pure Personal Icon because during this scene the gold medal only functions as an identity that

William Turner is the son of a Pirate. This is proven by William Turner's words that "The medal was a gift from my father".

b) Minute 05.33 Season 1 of *The Pirates Of The Caribbean* film

Pure personal icon. Elisabeth was looking in the mirror wearing the gold necklace, remembering the incident several years ago when she met Turner and found the gold necklace. The icon in this scene is PPI because the gold necklace with the Jolly Roger logo does not have any function in this scene.

c) Minute 06.40 Episode 1013 One Piece Anime

Pure Personal Icon. In this Scene, The Spade Pirates, led by Ace come to Wano Country to defeat Kaido and save the children being held captive at Kaido's

headquarters. However, the desire to defeat Kaido was dashed becaue Kaido was not at the headquarters and Ace instead met Yamato, Kaido's son, as a result their battle could not be stopped. Even though members of the Spade Pirates managed to save the children held hostage by Kaido, Ace and Yamato continued to fight until finally Yamato also said that he also disagreed with his father. The icon in this scene is PPI because the Jolly Roger-shaped mask, tattoos and necklace worn by the character named Skull do not have any function, and are only used by the character Skull.

d) Minute 22.37 Episode 918 One Piece Anime

Pure Personal Icon. In this scene, three top officials of the Beast Pirates, namely King, Queen, and Jack, are discussing the weapons business in Kuri City. Of the three high-ranking officials, the King and Queen never got along and hated each other, this was proven by the conversations between the two people who always belittled each other. Of the three bigwigs, Jack is the weakest and is always intimidated by the King and Queen. The icon in this scene is PPI because the tattoo with the Jolly Roger image only has a function for Queen, its function is as personal identity which shows that Queen is a Pirate and has a high position in the Beast Pirates.

e) Minute 06.46 Episode 992 One Piece Anime

Pure Personal Icon. This scene tells that the entire Luffy alliance is disguising themselves as Kaido's men to infiltrate Kaido's headquarters. They divided into small groups and entered through various doors of Kaido's headquarters so as not to be discovered. In this scene, Jinbei collaborates with Robin to infiltrate through the Middle Door by disguising himself as Kaido's subordinate and is tasked with saving Momonosuke from Orochi and Kaido's forces. The icon in this scene is PPI because the Jolly Roger symbol on Jinbei's belt has no function at all and the symbol only refers to himself.

2) Pure Local Icon

In the *Pirates of the Caribbean* Season 1,2 and the *One Piece* Anime from Episodes 890 to 1065, there are 5 PLI icons that can be found. Among them are:

a) Minute 37.57 Season 2 of The Pirates Of The Caribbean film

In an effort to avoid the Kraken, Jack attempts to sail to a nearby island. Unfortunately, he and his ship ended up stranded on the Pelegostos Islands, a tropical forest inhabited by cannibals. Some of the crew were later eaten by cannibals and their bones were used to imprison the surviving crew; Jack himself was made chief of the tribe by them. This scene tells that the Pelegostos Tribe intends to burn Jack Sparrow with the aim of freeing the god who resides in Jack Sparrow's body. The Pelegostos tribe is characterized by dressing up like the living dead and wearing skull or Jolly Roger hats. The Icon in this scene Is PLI because the skull is only a characteristic of the Pelegostos tribe.

b) Minute 21.27 Episode 899 One Piece Anime

Pure Local Icons. In this scene, members of the Heart Pirates are monitoring the situation of the Kuri Desert. They accidentally see Luffy and Zoro fighting with Hawkins, a member of the Beast Pirates. From the results of their monitoring, they gave a report to the chairman of the Heart Pirates, that they had seen Luffy and Zoro fighting with Hawkins. The icon in this scene is PLI because the Jolly Roger

depicted on their clothes is shaped differently from the Jolly Roger in general.

Therefore, the Jolly Roger on their clothes indicates the identity of the Heart Pirates.

c) Minute 13.39 Episode 911 One Piece Anime

Pure Local Icon.In this scene, Kinemon, a samurai from Wano Country, asks Luffy and Trafalgar for help to form an alliance to defeat Kaido. Kinemon explained the circumstances of how Wano Country was colonized by Kaido, so he, Kanjuro, Raizo and his master Momonosuke left Wano Country to look for allies with the aim of defeating Kaido. However, while looking for these allies, Kinemon and his friends were separated in the ocean until they met Luffy and Trafalgar. The icon in this scene is PLI because the Jolly Roger symbol functions as the identity of the Straw Hat Pirates, and the Jolly Roger is not owned by other pirates in the One Piece Anime.

3) Pure Cultural Icon

In the *Pirates of the Caribbean* Season 1,2 and the *One Piece* Anime from Episodes 890 to 1065, there are 4 PCI icons that can be found. Among them are:

a) Minute 04.14 Season 1 of The Pirates Of The Caribbean film

In this scene, William Turner is swept away by the ocean and is found by the aristocrat, Elizabeth Swann. At that time, William Turner was caught wearing a gold necklace with the Jolly Roger logo. Because for William's safety, Elizabeth lied to the Commodore that she had found nothing on William Turner, because if the Commodore found out that William was a descendant of pirates, William would most likely be executed. This icon is classified as PCI, Pure cultural Icon because the gold necklace in this scene does not have any function and the gold necklace is known as a pirate symbol.

b) Minute 05.27 Episode 994 One Piece Anime

Pure Cultural Icon. This scene tells that Kaido and Big Mom will form an alliance to find One Piece. Therefore, Kaido wants to make Wano Country a pirate base and wants to make Wano Country a weapons factory to strengthen his pirate

fleet. However, Shogun Orochi as the leader of Wano Country felt betrayed by Kaido and his alliance, and warned Kaido that he was the official leader of Wano Country. However, Kaido ignored the warning and then beheaded Orochi and gave him the choice of whether Orochi's subordinates wanted to form an alliance with Kaido. The icon in this scene is PCI because the Jolly Roger flag is the identity of the Kaido Pirates and has a function as a warning to the people of Wano that the Kaido Pirates will rule Wano Country.

c) Minute 20.30 Episode 1019 One Piece Anime

In this scene, Otama, Nami and Usopp come to save Franky from Sasaki's attack. Before Otama came to save Franky, Otama used his ability to turn the Beast Pirate Gifters into his friends. Gifters are Kaido's pirate members. Gifters have a unique body shape because they have half human and half animal bodies resulting from eating devil fruit engineered by Caesar Clown, an evil professor. With this body shape, Gifter members also have strength like real animals. The Jolly Roger icon in this scene is PCI because the pirate symbol has no function at all, and is only used on the Beast Pirates' armor division.

d) Minute 11.47 Episode 1058 One Piece Anime

Pure Cultural Icon. The symbol used on the clothes of Kaido's men is a symbol that represents a pirate, also known as the Jolly Roger. Kaido's men are facing the Fire Ghost which can burn everything, the Fire Ghost comes from Kanjuro because Kanjuro lost the fight against the Akazaya Nine so Kanjuro use his last strength to draw the Fire Ghost. The icon in this scene is PCI because the Jolly Roger symbolizes pirate identity in general, not as an individual or group identity and the Jolly Roger does not have any function in this scene.

4) Functional Personal Icon

In the *Pirates of the Caribbean* Season 1,2 and the *One Piece* Anime from Episodes 890 to 1065, there are 6 FPI icons that can be found. Among them are:

a) Minute 06.03 Episode 1017 One Piece Anime

In this scene, a three-person alliance, including Kid, Luffy, and Trafalgar Law, is fighting Kaido. And the three people used their respective strengths to defeat Kaido. Luffy with the power of haki and his devil fruit power which can turn himself into rubber, Trafalgar with his devil fruit power which can form its own dimension so it can dissect and separate someone's body, and Kid with his magnetic power which can form anything made of iron. However, with the strength of these three people, Kaido did not suffer any injuries at all and instead underestimated the strength of these three people. The icon in this scene is FPI because Kid has the power to turn iron into a skull-shaped weapon.

b) Minute 14.47 Episode 1000 One Piece Anime

Functional Personal Icon. In this scene, Usopp is showing his strength by shooting an explosive bomb, which is one of Usopp's characteristic weapons. Usopp has the nickname "God Usopp", a sniper specialist from the Straw Hat Pirates,

Usopp has a weapon that resembles a slingshot and the slingshot bullets have three characteristics, namely smoke bombs to block the enemy's vision, explosive bombs to destroy something or defeat an opponent, and plant bombs, the plant immediately grows and can defeat the opponent. The icon in this scene is FPI because the weapon that can emit smoke bombs in the shape of a Jolly Roger is only owned by Usopp.

c) Minute 08.54 Episod 949 One Piece Anime

Queen is one of three high-ranking members of the Beast Pirates who have chemical weapons. Queen's chemical weapons have many types and are very deadly. For example, in this scene, Scorpion, as Queen's subordinate, use chemical weapons made by Queen to torture prisoners in Udon prison. The side effects of these chemical weapons cause green spots to spread from one point throughout the body, high fever like burning all over the body, blood will come out and then, the victim will be in pain and will transmit the disease to other people. The icon in this scene is FPI because this icon has a function and this function is only found in the character Queen, this is proven by the Jolly Roger in this scene being a characteristic of the side effects of chemical weapons that only Queen has.

d) Minute 03.47 Episod 899 One Piece Anime

In this scene, Luffy and Zoro cross the barren desert to take Otama to the Flower Capital to look for a doctor to save Otama who is sick. However, Kaido's evil underling, Hawkins, stands in their way by provoking them into fighting him. Zoro is forced to fight Hawkins on Komaciyo's body, Komaciyo is Otama's pet giant lion. Hawkins is a pirate who has the power of tarot cards to predict the future and has the ability to be immune to attacks by taking other people's lives to use as straw dolls as extra lives. This icon represents FPI because tarot cards have a function for Basil Hawkins and tarot cards are a characteristic of Hawkins' strength which is not possessed by other characters in the One Piece Anime.

5) Functional Local Icon

In the *Pirates of the Caribbean* Season 1,2 and the *One Piece* Anime from Episodes 890 to 1065, there are 9 FLI icons that can be found. Among them are:

a) Minute 15.43 Season 1 of The Pirates Of The Caribbean film

In this scene, Elizabeth Swann falls into the sea, accidentally hinting at where the last piece of gold is. The piece of gold that is made into a necklace will later function to remove the curse of all the Barbossa Pirates and Captain Jack Sparrow. The icon in this scene is FLI because the gold necklace gives a sign of its existence when it falls into the sea.

b) Minute 39.26 Season 1 of The Pirates Of The Caribbean film

Functional Local Icons, In this scene, Elizabeth Swann threatens the Barbossa Pirate crew by sinking a gold necklace into the ocean if Captain Barbossa does not grant Elizabeth's wish. Afraid of this threat, Captain Barbossa was forced to grant Elizabeth Swann's wish. The icon in this scene is FLI because the gold

necklace functions as a negotiation tool with Captain Barbossa who will later be able to remove the curse of immortality on all of Barbossa's pirates.

c) Minute 34.09 Season 2 of The Pirates Of The Caribbean film

Jack Sparrow was stranded on an island with his crew, but bad luck befell
them all, they were captured by the tribe that inhabited the island. And the worst
thing happened to Jack Sparrow, he was considered a god by the local tribe.
Therefore, the Pelegostos Tribe intends to burn Jack Sparrow with the aim of
freeing the god inside Jack Sparrow's body. In this scene, Jack Sparrow will be
burned by the tribe, but before that, Jack Sparrow is invited to sit in the king's chair
and can rule as he wishes. The icon in this scene is FLI because the chair containing
the Jolly Roger represents power and only kings can sit on the throne and in this

scene Jack Sparow is considered king by the Pelegostos tribe.

d) Minute 11.19 Episode 1000 One Piece Anime

In this scene, Franky's vehicle turns into a giant robot to defeat the enemy. The robot has a shield on the chest which functions for self-protection and when Franky shoots laser beams from his body. The robot is called Iron Pirate. The icon in this scene is FLI because the Jolly Roger-shaped shield has a self-protection function for Franky and to attack his enemies. The Jolly Roger is also the identity of the Straw Hat Pirates.

e) Minute 13.56 Episode 890 One Piece Anime

Functional Local Icon. This scene recounts the war at Marineford, when the Whitebeard Pirates wanted to save Ace from the death penalty. The rescue mission failed and Shirohige died by Marshall D Teach. Teach was Whitebeard's subordinate who betrayed him and during the Marineford war, Teach killed

Whitebeard to take his power. Shirohige dies and remembers his past when he founded his Pirate Group. The icon in this scene is FLI because the Jolly Roger is the identity of the Whitebeard Pirates, because the Jolly Roger is not owned by other pirates in the One Piece Anime. Apart from that, the Jolly Roger was a sign of territory because Whitebeard was a Yonkou who had power under his protection.

6) Functional Cultural Icon

a) Minute 1.22.42 Season 1 of The Pirates Of The Caribbean film

Functional Cultural icon, this scene tells the story of when pirate member Captain Barbosa is pulling the Jolly Roger pirate flag to warn pirate member Captain Jack Sparrow to surrender. However, Captain Jack Sparrow's crew ignored the warning and a war broke out between the two pirates. The icon in this scene is FCI because the Jolly Roger flag is used by pirates to give a warning or threat to ships that will be attacked.

b) Minute 04.51 Season 1 of The Pirates Of The Caribbean film

Functional Cultural Icons. In this scene, it tells that all of Jack Sparrow's pirate crew are carrying out a coup against their captain Jack Sparrow, so that the Jolly Roger flag is raised and results in William Turner, the son of the bootstrap, being thrown off the ship. Coincidentally, Elizabeth's royal family passed through the sea and saved William. The icon in this scene is FCI because the Jolly Roger flag has the function of providing a threat to the enemy and indicating the resistance of pirate members to their captain.

c) Minute 14.31 Episode 1009 One Piece Anime




Figure 4. 23 Beast Pirates in One Piece Anime

Functional Cultural Icon. This scene tells the story that the Beast Pirates' men are blocking Yamato. Yamato is Kaido's son who doesn't agree with his father's

behavior, therefore Yamato wants to rebel against Kaido but Kaido's men always stop him, for example in this scene when Yamato wants to go save Momonusuke. However, the entire armor division is Kaido's men confront Yamato. Momonosuke himself is the son of Oden, a king from Wano Country, and a friend of Yamato. The icon in this scene is FCI because the Jolly Roger on the armor division's shield has no function and the Jolly Roger is different from the Jolly Roger from the Beast Pirates. The symbol was only used as a symbol on shields by a group of members of the Division armor Beast Pirates.

2. Pirates Narrative as seen in *Pirates Of The Caribbean Movie* and *One Piece*Anime

Symbolic interactionism is often referred to by the abbreviation SI. According to in the communication dictionary, interaction is a process of influencing behavior or communication that is established between members of society. Symbolic itself is symbolizing something. (Effendy, 1989). From these words it can be concluded that every human interaction can produce a symbol. In this research, the Jolly Roger symbol depicts the pirate character in the film Pirates of the Caribbean and the anime One Piece, including:

Jolly Roger's narrative in building the

William was found and raised by Governor Weatherby Swann, so William has a good family relationship with Governor Weatherby's family. This was proven when William tried to save Elizabeth Swann from Captain Barbossa's custody as an effort to repay Governor Weatherby Swann and his love for Elizabeth Swann.

This is proven in this scene, when Jack Sparrow is about to be hanged by the government, William Turner comes to save Jack Sparrow at the risk of his own life.






Figure 4. 30 Elizabeth Swann in Pirates Of The Caribbean Movie






Figure 4. 38 King in Anime One Piece






Figure 4. 48 Queen's chemical weapons in Anime One Piece




Figure 4. 50 Black Maria in Anime One Piece

B. Discussion

Finally, the researcher will discuss the research findings above which

discuss how the Jolly Roger is included in the Icon Theory classification. Then how

does the Jolly Roger Icon build the Pirate narrative in the film *Pirates Of The*

Caribbean and Anime One Piece? In analyzing the Jolly Roger, researcher need to

consider how the Jolly Roger can influence the course of the story by looking at the

nature of a character who use the Jolly Roger symbol from the social interactions built in the film. Then researcher can classify them into Icon Theory and into Symbolic Interaction Theory. Then the researcher limits the objects studied to make the research easier and so that the research is more focused on the object being studied. From the research conducted, the Jolly Roger in the *Pirates of the Caribbean* film and the *One Piece* anime is found on clothing, weapons, tattoos and flags and has a different meaning when used in each different scene.

Clothing is one way to get to know the culture and history of an area. Clothing also enables the identity of a particular individual or group (Mckee, 2022). What a person wears can reveal their religion, traditions or values, it can reveal their history or uniqueness. Therefore, when clothing has the Jolly Roger symbol and is used for social interaction, it will create a certain meaning for the wearer. Likewise, the Jolly Roger found on flags, tattoos or weapons will have a different meaning for the user.

From research conducted by researcher, researcher also found data that the pirates that we have known had evil or cruel characters. It turns out that in the research that has been carried out, pirates are also described as having the character of faithfulness and helpers. This is proven by the actions of several characters in the film *Pirates of the Caribbean* or the anime *One Piece*. One example is the character Ace in the One Piece anime who wants to save his friend in Wano Country, even though this rescue carries a big risk.

CHAPTER V

CONCLUSIONS, IMPLICATIONS, AND SUGGESTIONS

A. Conclusions

The results of the research show that the data found from the Icon Theory classification amounted to 36 data and the most dominant was the Functional Local Icon category data. This data shows that the Jolly Roger symbol represents a group of pirates and the Jolly Roger has a function so it is classified as a Functional Local Icon. Meanwhile, the narrative formed by Jolly Roger using Symbolic Interaction Theory amounts to 46 data and the most dominant is Strong's data. This data shows that Pirates are described as having strength. From the results of this research, there are differences between Caribbean pirates or western pirates, represented by the *Film Pirates of the Caribbean*, and eastern pirates, represented by the *One Piece Anime*. From this research, pirates from the west are depicted as having a scary appearance, plus using accessories such as prosthetic legs, prosthetic hands, and one blindfold. In contrast to eastern pirates who promote eastern traditions, eastern pirates still wear their traditional clothes as a cultural symbol.

B. Implications

Finally, the researcher will discuss this research regarding the research findings above which discuss the classification of Jolly Roger into Icon Theory and the meaning of Jolly Roger in building pirate narratives. The dominant data are related to each other, in other words the dominant data found from the first question

will help the second question. Researcher will draw conclusions from these two questions.

C. Suggestions

1. For the other researchers

For other researcher, this research discusses the study of Icon Theory and Symbolic Interaction with the research object Jolly Roger in the film *Pirates of the Caribbean* and Anime *One Piece*. This research will help future researchers to look for references related to Icon Theory or Symbolic Interaction Theory, or related to the Jolly Roger Research Object. Henceforth, researchers can find something new from the results of this research.

Researcher suggest analyzing the symbols of superheroes that characterize them using Icon Theory and Symbolic Interaction. Or further researcher can analyze research objects about pirates or the Jolly Roger in terms of color. Future researcher can use the book An Introduction to the Study of Popular Culture (1992) by Nachbar and Lause as a research reference.

2. For the readers

It is hoped that the results of this research will provide readers with a further understanding of the study of Symbolic Interaction and Icon Theory. Thus, this topic makes readers understand two things: Classifying Jolly Roger into Icon Theory and how Jolly Roger builds a pirate narrative in a film using Symbolic Interaction Theory. First, by studying Icon Theory we can find out whether a

symbol has a function for itself or in the surrounding environment and whether the symbol has an impact on the surrounding environment.

Secondly, studying Symbolic Interaction will help readers understand social interaction. From social interactions, symbols emerge that have meaning in the surrounding environment. studying Symbolic Interactionism will help readers understand that by establishing relationships with other people in a society, self-identity can be understood.


